#### **The O AFC applauds the Federal Government Support for Volunteer Firefighters in Budget 2024**

**[AJAX, ON]** The Ontario Association of Fire Chiefs (O AFC) applauds the Federal Government in today's 2024 Federal Budget.

The Government of Canada to increase tax credits for volunteer firefighters and search and rescue volunteers by doubling the credit from \$3,000 to \$6,000 for the 2024 tax year and subsequent tax years.

This increase will particularly benefit rural communities where firefighters are most often volunteers and are confronting increasingly more frequent wildfires as well as recruitment and retention issues. These investments will help ensure that essential first responders are better supported in the work they do to keep Ontarians safe.

Ontario is home to 437 fire departments, both career and volunteer, that operate around the clock to keep over 15 million Ontarians safe.

The O AFC is confident that these measures will significantly contribute to the safety and effectiveness of fire services across Ontario and a great step forward for volunteer recruitment and retention.

The O AFC which is a standing member of the National Advisory Council (NAC) with the Canadian Association of Fire Chiefs (CAFC) also applauds the Government of Canada's investment in Indigenous Communities. First Nations Emergency Management and Preparedness among many facets like \$20.9 million over three years distributing fire alarms and fire extinguishers to homes, as well as fire related education.

The O AFC is very thankful for all the hard work the CAFC has been doing to advocate for fire at the Federal level. The O AFC will continue to work with all partners to ensure fire and life safety to all Ontarians. A great start and more work to do, together.
